New Sight

Jesus said, "I came into the world for judgment so that those who do not see may see, and those who do see may become blind." (John 9:39)

We know that when Jesus was here he performed miracles. Those miracles took a variety of forms, turning water into wine, walking on water, casting out demons, feeding five thousand people from five loaves of bread and two fish. The miracles that got peoples 'attention tended to be the healings he performed. There must have been a lot of sick people back then because we are told many times that when Jesus entered a town people came to him for healing.

When you consider the fact that he must have done a lot of healing it should make you wonder why it is that certain healings get described in detail. In many cases these are blind people who received sight because of Jesus. Why should the Gospel writers draw greater attention to a blind person receiving sight than most other healings?

Jesus seemed to like to use these healings as teaching moments. Opening the eyes of the blind could easily be compared to faith, as we can see in this month's theme verse. When Jesus says he came into the world so that people could see, we should know that he is not referring specifically to the blind he healed. Jesus means all of us. Jesus opens our eyes to see that he truly is God's Son, who has come into our world to offer salvation to all through his sacrifice on the cross and resurrection from the grave.

What makes this verse interesting is that there is a flip side to this. There are also those who become blind because of Jesus 'presence in the world. In this case, blind means to be one who refuses to see the truth; one who refuses to recognize Jesus as God's Son.

Simply by opening people's eyes, Jesus stands in judgment on all people: those who can see the truth, and those who refuse to see it.

Do-It-Yourself Bible Study

For our Bible study this month, let's look at a passage from John's Gospel that I did not include in our Sunday lessons. If you find this intriguing I hope that you will join others to go deeper.

John's Gospel is filled with instances of Jesus teaching people, but those who hear his teaching midunderstand what he is saying. In most cases the problem comes down to taking what he says too literally.

Read John 6:35-40.

When Jesus talks about "bread" his hearers assume it has something to do with that stuff we eat to stay alive, but Jesus has a different viewpoint. How would you define what Jesus means by the "the bread of life"?

Earlier Jesus had told the people that he is the bread of God which comes down from heaven and gives life to the world. Now Jesus is going to compare himself as the bread of life to the manna that God provided when the nation of Israel was in the wilderness back in Exodus.

Read John 6:41-51.

The confusion for Jesus' hearers arises from the fact that they hear "bread" and think of that stuff you eat. When you eat your stomach is filled, but as the "living bread" what does Jesus see as being different about what he brings to people?

Interestingly John's Gospel never describes what Jesus did with bread and wine at the last supper, but it does make a number of references to communion, just as it does here.

Read John 6:52-59.

When we eat we take food and turn it into the nutrients that keep us alive and healthy. Jesus assumes something similar happening at communion, but in a spiritual manner. What would you say we receive at communion?

Annual Report for 2020 - Area Food Shelf of New Richland

2020 – What a year! The one thing that did not change was the amazing support we receive from our sponsoring congregations. Thank you for your prayers, words of encouragement, volunteer time, donations of food, and financial gifts. We appreciate everything you do to keep the Area Food Shelf of New Richland going.

2020 meant changes in our operation. During the start of the Covid shutdown, Channel One provided the food shelves with "emergency boxes" for a minimal cost. The boxes were 20-30 pounds each and contained a variety of food. Because of your generosity, we were able to supplement the boxes with meat and produce. Folks drove up and we took the boxes to their cars. Restrictions eased and we are now allowing people to shop one at a time.

We increased the number of people served by 15% in 2020. The weekend food program for NRHEG (backpack program) was down in numbers of students receiving food, but we expect the number to climb when things return to normal.

Our volunteers have been amazing during these trying times. We would not operate without their dedication. Thank you to them for everything they do from unloading the Channel One deliveries, (the delivery of 250 emergency boxes – 7500 pounds!!), Putting the food away, working when the food shelf is open, receiving deliveries of donated food, assisting guests who need appointments, and the list goes on.

Thanks also to the churches that sponsor us. The support and dedication keeps our doors open. We are very grateful.
