The Power of Prayer

He said, "Cornelius, your prayer has been heard and your alms have been remembered before God."

(Acts 10:31)

Prayer can be a difficult and confusing subject for many of us. There are definitely times when our prayers seem like the message in a bottle thrown into the ocean by a castaway: sent off into the unknown with a vague hope that someone will respond.

The verse from the book of Acts that we are focusing on this month needs a bit of context. Cornelius has received a visit from Peter. Cornelius is a Gentile, one considered to be unclean to a Jewish person like Peter, but Peter has been encouraged by God to ignore all that and regard all people equally. Cornelius has been told to invite Peter to his home, which is a test run of Peter's willingness to receive Gentiles into the faith. Our verse is part of Cornelius' explanation of why he invited Peter to visit. It seems that a man in dazzling clothes appeared to him and spoke those words.

Wouldn't it be nice if our prayers were answered in this way? We send up the prayer and a man in dazzling clothes appears and tells us that our prayer has been heard, and by the way, your generosity to the poor has not gone unnoticed either. Unfortunately it rarely if ever works this way.

That does not mean that our prayers are not heard, and it does not mean that our prayers are ignored. Just because we do not receive some immediate confirmation we still trust that when we pray God is listening.

The interesting thing is that this trust we have that our prayers are heard is not the result of our praying. It makes no difference if the prayer we send up is long or short, fancy or plain, even the language doesn't matter. Because our trust is not in the way we pray, it is in the one who listens.

Do-It-Yourself Bible Study

For our Bible study this month, let's look at a reading from Luke's Gospel. If you find this intriguing I hope that you will join others to go deeper.

Read Luke 5:1-3.

Jesus has already amazed the people in his hometown of Nazareth with his teaching and healing, and they wanted him to stay. Jesus insists that the good news must be brought to others and here we see him doing just that. What do you think was going through Simon's mind?

At this point in his ministry, Jesus is traveling alone, so we are learning how he gathered his group of disciples. His first stop is at Simon's fishing business where he interrupts a fellow in the midst of his daily routine. Now this stranger gives Simon advice on how to do his job.

Read Luke 5:4-7. We tend not to appreciate the advice of people who don't know what we are doing who tell us how to do our job. A tired Simon agrees to follow Jesus's advice and it turns out well. What do you think is going through Simon's mind now?

We are told what happened, but we are not led to believe that this was a miracle. Either Jesus knows more about fishing than Simon or there is something else going on here. At this point it appears likely that Simon may wish to offer Jesus a job.

Read Luke 5:8-11.

As it turns out, it is not Simon offering Jesus a job to join him in his fishing business, but Jesus offering Simon a job to be his disciple. Why do you suppose Simon responded the way he does in verse 8?

Cross of Glory Council Minutes Dec 7, 2021

Present: Jerry Morstad, Pastor Steve, Linda Brekke, Paul Lynne, Steve Bakken Emily Wakefield, Jill Morstad.

President Jerry Morstad called the meeting to order. Pastor Steve led us in prayer. Pastor Steve then reported that the Christmas program would be presented this coming Sunday by the Wednesday school kids. Pastor also requested that the council approve a \$3,000 housing allowance that would allow him to take money out of his pension for a down payment on a house when he retires. There are no funds given to the pastor. Paul made a motion to approve a \$3,000 housing allowance for Pastor. 2nd by Steve. Motion carried. West Freeborn will need to approve as well. Jerry asked if there were guidelines for Pastor for visiting members at this time. Pastor stated he bases it on vaccination status. He has been able to provide some in home communion.

Secretary's report was read by Jill. Report approved with no additions or corrections. Treasurer's report was given by Linda. Paul made a motion to pay bills and Matt gave a 2nd to the motion. Motion carried.

Together we reviewed the budget vs actual from 2021 and then reviewed the proposed budget for 2022 all of which were prepared by our accountant Allyson Olson. We discussed the Payroll Protection Plan loan and the local contribution from L &D Ag. Jill made a motion to accept the proposed budget. 2nd was made by Steve. Motion carried and the proposed budget will be presented for the congregation to approve at the annual meeting scheduled for Dec 12th.

Christmas offering was discussed and Paul made a motion to give it to the New Richland Area Food Shelf. Matt made a 2nd to the motion. Motion carried.

The list of council members was discussed and that everyone was willing to continue in their current position. Even those not present had been contacted by either Jerry or Jill and were willing to remain. There aren't terms currently listed as that has become disrupted. The list of council members will be presented at the annual meeting for approval. Secretary position is still open.

Allyson had prepared an office account detail sheet and we discussed ongoing concerns with the copier. An additional cost had occurred for several months due to tech support that had been sought but that has been cancelled as soon as it was recognized. That was listed as "Just Answer" on the financial reports. The copier that was approved at the November council meeting has not been ordered as of yet. Toner that is more reasonably priced has been purchased and is currently working. Again it is an ongoing process.

Jerry and Glenn Ausen had been made aware that the parsonage stove was functioning poorly and is an older model. Jill and Karen Ausen were asked to look at replacement options and they were able to do that with Pastor Steve's wife Nancy. They chose a replacement stove from Sorenson's appliance in Geneva, pending approval from the council. It is a Maytag electric range with a 10 year warranty. The cost will be \$1,049. That cost will be shared 50/50 with West Freeborn. Paul made a motion that the stove be purchased using funds from the improvement fund. 2nd by Steve and motion carried. The stove should be available for delivery within the next couple of weeks. Steve made a motion for adjournment, 2nd by Matt. Motion carried. Meeting closed with the Lord's Prayer.
